

CERTIFICATE OF INSURANCE -- Full 2026 Season

Exhibitor shall provide a Certificate of Insurance ("COI") showing that Exhibitor has liability insurance with coverage terms and amounts listed below.

The COI shall designate "Krave Group, LLC" as the Certificate Holder, and shall contain an additional insured endorsement as stated below.

Certificate must include the following requirements:

- 1. WORKERS COMPENSATION INSURANCE: State Statutory Limits.
- 2. COMPREHENSIVE GENERAL LIABILITY: Required limits are \$1,000,000 per occurrence.
- 3. AUTOMOBILE LIABILITY: Combined bodily injury and property damage liability with a combined single limit of \$1,000,000.
- 4. WAIVER OF SUBROGATION: Provider's insurance shall contain a waiver of subrogation clause.
- 5. ADDITIONAL INSURED: KRAVE GROUP, LLC, Daytona International Speedway; Michelin Raceway Road Atlanta; Barber Motorsports Park, LLC; Barber Companies, Inc., Barber Vintage Motorsports Museum; Barber Motorsports Park 2, LLC; Barber Motorsports Park 3, LLC; Barber 603, LLC; George W. Barber, Jr.; Tram Rental, LLC; Bruno Hospitality, LLC; Eventive Sports Properties, LLC.; Zoom, Motorsports, LLC, Troon Golf, LLC.; Road America; The Ridge Motorsports Park; WeatherTech Raceway Laguna Seca, and the County of Monterey; Mid-Ohio Sports Car Course; Virginia International Raceway; Circuit of the Americas; New Jersey Motorsports Park; their respective parents, members, and affiliates, and their respective members, shareholders, officers, managers, directors, agents, servants, employees, volunteers, related or affiliated companies, successors, subcontractors and assigns.
- 6. Policy shall also be endorsed to provide that such insurance is primary insurance and that no separate insurance policy or self-insurance of the additional named insured shall be called on to contribute to any loss incurred in connection with the Exhibitor's performance.
- 7. The above-described coverage shall be maintained through the term of the Contract and the Exhibitor shall file with MotoAmerica a Certificate of Insurance (COI) evidencing that any insurance coverage required herein has been obtained and are currently in effect.
